

## **REGULATIONS OF THE PROMOTIONAL ACTION “XMAS ROULETTE – 2025”**

### **Article 1**

#### **Period of Operation**

1. The “XMAS ROULETTE 2025” promotion, hereinafter referred to as the Action, will take place on December 19, 20, 21, 25, 26, 27 and 28, 2025 (7 campaign days), between 6:00 p.m. and 2:00 a.m., simultaneously at Casino Estoril and Casino Lisboa.
2. The Action is organized by Estoril-Sol (III), S.A., the concessionaire for the operation of games of chance in the permanent gaming zone of Estoril, which in that capacity operates both Casinos referred to in paragraph 1.

### **Article 2**

#### **Participants**

1. The Action is intended to reward persons over 18 years of age who, meeting the legal and regulatory requirements to access the gaming rooms of the Casino where they intend to participate, have accumulated at least 5 points in their player account on the day of participation.
2. Participation is limited to 300 people per day of operation and per Casino.
3. Customers verify their eligibility to participate at the Loyalty desk of the Casino where they intend to participate and, after validation by the Loyalty team, receive a participation voucher which they must present before taking part in the Action.

### **Article 3**

#### **Mechanics**

1. The Action consists of a contest based on the game of Roulette, and for this purpose a roulette wheel will be installed next to each Loyalty desk, in the lobby of Casino Estoril and in the lobby of Casino Lisboa.
2. Customers eligible to participate under the terms of the preceding article may drop the ball once into the roulette wheel referred to in Article 2, with the help of a horn placed next to the roulette wheel. The ball will come to rest on one of the 37 numbers on the roulette wheel, from 0 to 36, corresponding to the respective prize.
3. Each participant may participate only once per day of the Action. An exception is made if the ball jumps out of the roulette wheel, in which case the participant may immediately make one additional drop.
4. The prizes consist of “play-only promotickets,” to be used on the gaming machines of the Casino where participation occurred, within 30 days from the date of award.

5. The stopping of the ball launched by the participant on one of the numbers on the roulette wheel gives rise to the award of promotickets with the characteristics described in the previous paragraph, with the following values corresponding to each number on the wheel:
  - a) 0 – €200
  - b) 2, 12, 15 and 24 – €100
  - c) 6, 9, 10, 13, 18, 29, 32, 35 – €50
  - d) 1, 3, 5, 7, 14, 16, 19, 22, 25, 26, 30, 36 – €20
  - e) 4, 8, 11, 17, 20, 21, 23, 27, 28, 31, 33, 34 – €10
6. Promotickets are subject to stock shortages on each day of participation, even if the number of participations has not yet reached 300.

#### **Article 4**

##### **Validity**

1. The “play-only” promotickets offered in this Action lose their validity if they are not used at the Casino where they were awarded within the period referred to in paragraph 4 of Article 3.
2. It is the participant’s responsibility to keep the promotickets referred to in the previous paragraph in good condition so that they may be used during the respective validity period. Estoril-Sol declines any responsibility and has no obligation to replace promotickets issued under this Action in the event of loss, misplacement, illegibility, or irreparable damage.

#### **Article 5**

##### **Irregularities**

1. The following are considered irregularities and result in the immediate loss of all benefits referred to in Article 3:
  - a) Participation or attempted participation by a person who does not meet the requirements set out in Article 2;
  - b) The provision of false, inaccurate, or incomplete identification data.
2. In addition to the provisions of paragraph 1, the provision of false, incorrect, or inaccurate information, as well as the presentation of irregular identification documents for registration purposes, may also subject the participant to the legally prescribed sanctions.

#### **Article 6**

##### **Final Provisions**

1. Estoril-Sol (III), S.A. reserves the right, at any time, to cancel this Action and any advantages associated with it.
2. Any omissions and doubts regarding the interpretation of these Regulations shall be decided by the Casino Management in accordance with applicable legislation, with the right of appeal to the Gaming Regulation and Inspection Service.
