

## Valentine's Day Campaign 2026 Regulations

### Article 1 Conditions

1. The promotional action "Valentine's Day Campaign 2026", hereinafter referred to as the "Action", aims to award specific offers to customers of Casino Estoril and Casino Lisboa who are enrolled in the Loyalty program with a complete registration and marketing consent.
2. The Action takes place during the gaming days of February 13 and 14, 2026, at Casino Estoril and Casino Lisboa. A "gaming day" is understood to be the continuous daily operating period that begins on the calendar day it designates and ends in the early hours of the following day.
3. The Action is organized by Estoril-Sol (III) – Turismo, Animação e Jogo, S.A., the concessionaire company of Casino Estoril and Casino Lisboa, hereinafter referred to as Estoril-Sol.

### Article 2 Participation

1. The Action is intended to reward persons over 18 years of age who, meeting the respective legal requirements, hold a complete registration to access the gaming areas at Casino Estoril or Casino Lisboa, are enrolled in the loyalty program, and have authorized the receipt of marketing communications by SMS and/or email.
2. To be eligible to participate in the Action, the persons referred to in paragraph 1 must accumulate at least 5 points in their player account at the Casino where they intend to participate, following the procedures below:
  - a) To participate, the customer must, between 6:00 p.m. and 2:00 a.m. on each gaming day on which the Action takes place, collect at the Loyalty Desk an LPStore ticket certifying that they have already accumulated the 5 points and that their daily participation in the campaign has been registered.
  - b) Upon arriving at the Action area, the participant must hand the ticket to a promoter, who will accompany the participation.
3. Each participant may only take part in the Action once on each of the days on which it takes place.
4. Estoril-Sol, through its employees, namely those assigned to the Action, may request the presentation of a valid official identification document whenever it is necessary to verify the participant's identity.

## Article 3

### Mechanics of the Action

1. To enable participation in this Action, each Casino will have a touchscreen device called the “Love Slot”. Participation is completed when the duly approved participant touches the screen to activate the movement of three reels. At the end of this movement, the reels will display a combination of symbols, and each combination corresponds to a specific prize, as follows:
  - a) 3 red hearts – €100 in playable-only promotickets;
  - b) 3 pink hearts – €50 in playable-only promotickets;
  - c) 3 blue hearts – €20 in playable-only promotickets;
  - d) 3 yellow hearts – €10 in playable-only promotickets.
2. Participation always results in the award of one of the prizes referred to in paragraph 1, per participant, and ends at the moment the prize is awarded.
3. The prizes referred to in paragraph 1 of this rule consist of playable-only promotickets, in the amount corresponding to each combination obtained, usable at the Casino where they are awarded, with a validity of 30 days.
4. Each customer eligible under Rule 2 is entitled to participate in the Action once on each gaming day on which the Action takes place, as soon as they accumulate the minimum of 5 points in their player account.
5. Customers should note that participation in the Action is only possible between 6:00 p.m. and 2:00 a.m. on each of the gaming days on which it takes place and must therefore accumulate the minimum of 5 points within a timeframe compatible with participation. Participations before 6:00 p.m. or after 2:00 a.m. will not be accepted.

## Article 4

### Changes

1. Estoril-Sol reserves the right, at any time, to modify, suspend, or cancel the Action, namely in the event of unforeseen or exceptional situations, or if circumstances or actions arise that may indicate the practice of unlawful acts.
2. In the event of modification, suspension, or cancellation of the Action, no liability may be attributed to Estoril-Sol.

## **Article 5**

### **Privacy Policy**

1. Estoril-Sol does not keep any specific record of participation in the Action, carrying out only the verification necessary to limit participations per person, in accordance with Rules 2 and 3.
2. Participants will not be required, as a condition for participating in the Action, to provide any personal data beyond those contained in their customer record under paragraph 1 of Rule 2.

## **Article 6**

### **Final Provisions**

1. Any matters not provided for herein shall be resolved by Estoril-Sol.
2. Participation in the Action is prohibited for all employees, collaborators, and interns of Estoril-Sol or of companies that have a shareholding relationship with it or with which it has such a relationship, as well as for any collaborators of external companies that carry out their activity within the Estoril Gaming Concession.
3. Appeals against decisions taken by Estoril-Sol in the application of these Regulations or in matters related to the Action may be lodged with the Gaming Regulation and Inspection Service of Turismo de Portugal.
